**S.Thomas College, Gurutalawa – O B A - DIRECTORY OF MEMBERS**

Three of the letters sent as above have so far been returned by the Postal Authorities with the endorsement "Left Address".

A further 06 members were written to. A list is enclosed marked 'B'.

I shall transmit to you any further Data Sheets received by me from time to time for inclusion in the Directory **AND ALSO TO UPDATE YOUR OWN MAILING LIST, WHERE NECESSARY.**

I am also enclosing a specimen of the Circular Letter dated August 07,2001 marked "C" sent to 109 Members (together with a list marked "D") **WHOSE NAMES APPEAR IN THE REGISTER OF MEMBERS, BUT NOT IN YOUR MAILING LIST. AS I HAD POINTED OUT, THERE ARE ALMOST 300 MEMBERS WHO FALL IN TO THIS CATEGORY. THE ADDRESSES OF ALMOST 168 OR SO OUT OF THE SAID 300 ARE NOT AVAILABLE.**

Mr.C F Stork who you say recently accosted you at Liberty Plaza and found fault for being "marginalized" belong to this unfortunate band of 300 whose names are not in your Mailing List, but appear in the Register of Members. In Mr. Stork's case too no address is set out against his name in the Register. There are many more and they will no doubt be hurt at what has been happening. **I AM SURE IF THE NAMES AND WHEREABOUTS OF THE OFFICE BEARERS ARE KNOWN**

**MEMBERS LIKE MR.STORK WILL COMMUNICATE WITH YOU INSTEAD OF VICE VERSA.** You will appreciate that this is unfortunate. Much time has been allowed to elapse without any communication with them. That is why I suggested that a Paper Notice be inserted even at this stage to “call the flock in,” to be copied in the News Papers of the Principal countries/cities involved and seek the assistance of our branches in those Countries/cities.

It is also unfortunate that whoever who entered these names in the Register of Members

- a) did not insert the address contemporaneously and/or
- b) did not insert the new address when deleting the old address.

As I mentioned to you there were so many Members who complained that their requests to record their new addresses had been ignored several times over. The task now to ascertain the current address is an uphill one, but with the will to do so, it can be done.

I hope the Executive Committee will not be too busy to address their minds to these matters too which concern the OBA and eventually the College.

I trust that you are aware that there are 04 Members of the Current Executive Committee whose names do not appear in the Register of Members.

There appears to be 01 Member of the Current Executive Committee whose name does not appear either in the Register of Members or even in your Mailing List.

Some past Members of the Executive Committee too do not have their names either in the Register of Members or in your Mailing List. I have pointed out some of their names to you.

The name of G.T. De S Jayasinghe of No. 720/5 Talangama North, Talangama should be included in the Directory. It had been left out through inadvertence.

Although we have as yet not been informed of the composition of various Sub Committees as undertaken by the Senior Vice President, I hope the finalisation of the Directory has been entrusted to one of them. As indicated earlier I will be happy to give any assistance or clarification that may be required by such Sub Committee.

Many members who telephoned me inquired as to when the Directory will be finalized. **DELAY WILL NECESSARILY MEAN THE DATA SUBMITTED WILL BE OUT DATED.**

I trust you will table this letter before the Executive Committee.

**ST. THOMAS COLLEGE GURUTALAWA OLD BOYS ASSOCIATION DIRECTORY OF MEMBERS.**

1. I am assisting Mr. Upali Jayawardene, our Secretary to complete the task of finalising our proposed Directory of Members early.
2. I am not sure whether we knew each other in College or whether we have met before. I studied at S.T.P.S. Bandarawela from 1952 – 1957; at S.T.C. Gurutalawa from 1958 – 1962 and thereafter at S.T.C. Mt. Lavinia. Since 1970 I have been in Colombo associated with M/s. D.N. Thurairajah & Co., and Ceylon Secretarial Services Ltd who are Lawyers and Company Secretaries respectively.
3. Last September the Secretary dispatched to the members (using a Mailing List of approximately 325 Members) Data Sheets to be perfected and returned for inclusion in the **Directory**. Only 53 Members responded. We felt a personal visit to the addresses as furnished to us by the Secretary may perhaps bring forth a better response.
4. I utilised the resources and facilities including the Professional Assistants, Private Investigators and Secretarial staff at my Secretariat. We visited almost 175 such addresses of the membership in the CMC areas and in Ratmalana, Mt. Lavinia, Dehiwala, Kotte, Rajagiriya, Nawala and Nugegoda in June/ July 2001.
5. We were thus able to have perfected an additional 160 Data Sheets within 03 weeks which were fed into the computer.
6. We prepared a draft Directory of Members which we submitted to the Secretary on July 2001. for finalisation of the Cover, Layout, Presentation etc.
7. We have now arranged our representatives **to visit** a few outstations too in the near future.
8. Your Data Sheet has not been amongst those received todate, probably because your name is not in the Secretary's Mailing list although you are Member and your name is in the Register of Members. There are about 300 members like you we are endeavouring to communicate with.
9. We are therefore sending you herewith a Data Sheet for perfection and return to us by post or fax, as it may not be possible to visit you within a week or two.
10. This letter is addressed to you to your address as available in the Register of Members. We hope it is your correct address and our effort is not in vain. Please take time to perfect the Data Sheet and return same to us **TO THE ABOVE ADDRESS**. We assure you that we shall send an Addendum to the Secretary so that a more complete Directory of Member **INCLUSIVE OF YOUR PARTICULARS** could be printed and made available for private circulation amongst the Membership **at an early date**.

11. Please feel free to telephone or write to us if you require any clarification.
12. **Please ask your friends who were at Gurutalawa and who are not members to join the OBA.** A Specimen of the Application for Membership is enclosed for enrolment and inclusion in the Directory of such friends.
13. Looking forward to your co operation and hoping that we will together be able to ensure that Gurutalawa can soon keep pace with the progress being made by the other branches, of the Thomian Family.
