**6. Headmaster's Report**

College had reopened on January 7. Mr. Mahen Ranasinghe had visited College on December 23 and seen the Blanchard Dormitory toilets being constructed.

**7. Adoption of Minutes of Previous Meetings**

The Minutes of Meeting No. 10 of 2007/2008, held on December 15, 2007 was accepted as a true record, proposed by Mr. P. Dayabaran and seconded by Mr. Kuru Utumpala

**8. Matters Arising**

- a. Mr. Mahen Ranasinghe advised that Mr. Lakshman Jayatilaka was preparing a draft on the request for the appointment of separate OBA Representatives to the Board of Governors. He had already contacted the Secretaries of the OBAs of STC Bandarawela and Colpetty and they were supportive of the idea.
- b. Decision on Headmaster's proposal to make Mr. Jacques Huyghebaert an Honorary Member of the OBA, was deferred to the next Meeting.
- c. Mr. Mahen Ranasinghe advised that the Rotary Club of Australia had transferred almost the full cost of clearing and demurrage to the Rotary Club of Welimada. There had been a shortfall of a few thousand Rupees due to the exchange rate and this would be divided equally between the OBA and the Rotary Club of Welimada. Rs. 100,000.00 out of Rs. 140,000.00 taken from the OBA, to clear the computers, had already been credited to the current account at Commercial Bank. Mr. Nihal Wanniarachchi suggested that confirmation of the exact amount received from the Rotary Club of Australia should be obtained from the Rotary Club of Welimada, to avoid and claims by them later and Mr. Mahen Ranasinghe agreed to get it from them.

**9. Treasurer's Report and Annual Accounts**

The annual accounts were tabled by the Treasurer and it was accepted, subject to the addition of Rs.61,000.00 under expenditure, for the donation made to College for the prizes at the prize giving, proposed by Mr. S. Rajmohan and seconded by Mr. Atula Kumaranayake. The annual accounts are attached.

The current account at Standard Chartered Bank had not been closed yet and, as some of the standing orders from donors were still being credited to it.

**10. Junior Dormitory Toilets**

Mr. Mahen Ranasinghe tabled the quotation submitted by the Contractor, through the Headmaster, for the refurbishing of the 4 night toilets, in the sum of Rs.177,825.00. He had inspected these toilets with Mr. Jacques Huyghebaert and the Contractor during his visit on December 23 and discussed all details. The Contractor had agreed to complete all work before the AGM. The Ex-Co approved the quotation.

**11. Annual General Meeting**

The Notice of AGM had been advertised in the Daily News and Weerakesari on Saturday, January 5 and Sunday, January 13, 2008 respectively. It would be advertised in Lankadeepa on Sunday, January 20, 2008.

**13. Any Other Business**
