REPORT OF THE SUB-COMMITTEE FOR MEMBERSHIP November 28,2002

1. <u>MEMBERSHIP</u>

There are 813 Members on the Register as at date. 5 Members have joined since the last Meeting, namely, Mr.K S K Suresh, Mr.Harish Nilaweera, Mr. R A T Pushpika, Mr.R A T Warnaka and Mr.K S Karuneshwaran. Mr.Harish Nilaweera is an Old Boy of the 1958-1962 era, and Attorney-at-Law and Solicitor presently resident in UK. He also made a generous contribution towards the College Development Fund on his recent visit to Sri Lanka. Their membership cards have been duly perfected, laminated and dispatched. Since March 02,2002 a total of 67 Members have joined the Association.
